Launch Date;

This is the date you wish your vessel placed in the water. Customers must have their vessel prepared for launch prior to this date. MRC will do its best to launch your boat on the assigned date, however MRC cannot guarantee an exact date due to influences beyond our control.

Winter Storage Customers;

Who have a "2017" Summer Slip contract paid in full at either MRC and/or CPM have until May 15, 2017 to prepare your vessel for launch. All others are required to be ready for launch no later than April 30, 2017, with potential for land storage fees accruing after that date, **(Winter Storage Contracts expires March 31, 2017)**. Vessels will be launched based on request dates as well as yard position. Any vessel not ready for launch and requires relocation will be charged a re-blocking fee of 10.00 per foot.

Inboard, Stern drive & Outboard Engines, Tune Up Details

- ** Spark Plugs Removed and Replaced**
- ** Ignition Components inspected and timing checked**
- ** Linkage lubricated and adjusted**
- ** Carburetors adjusted**
- ** Efi engines may require computerized**

Manasquan River Club Rules of the Road

- ** Spring services will not be provided with a credit card authorization form completed.
- ** All fees for storage and/or service must be paid in full prior to launch.
- ** Open Flames and/or tools that produce open flames are prohibited.
- ** Sanding and Painting is prohibited while in slips, tarps and vacuums must be used to collect waste produced by any process employed while in the storage yard. Spray painting is prohibited in any area of the marina.
- ** Shrink wrap cannot be co-mingled with trash, and placed in assigned dumpster.
- ** Environmental Fees are added to service invoices to assist maintaining a environmentally safe and compliant marina.
- ** The discharge of sewer and/or oil in the marina waters or on land is prohibited.
- ** Manasquan River Club assumes no responsibility for the safety of any vessel moored at the docks after launching. MRC will not be held liable for fire, theft and/or damage to vessel, equipment or any property associated with vessel.

I hereby authorize the repair work detailed to be done with the necessary materials. MRC and their employees may operate my vessel for the purpose of testing, inspecting and/or delivering at my risk. I understand that extending credit on my behalf constitutes a mechanic's lien on my boat to secure the amount of repairs. MRC will not be held responsible for loss or damage to vessel in case of fire, theft, accident or any other cause beyond our control.
