A \$500.00 DEPOSIT IS REQUIRED WITH THE CONTRACT BY OCTOBER 31, 2018 WITH THE BALANCE DIVIDED INTO THREE INSTALLMENTS AS FOLLOWS: JANUARY 28, 2019, FEBRUARY 28, 2019 AND MARCH 28, 2019. WINTER STORAGE CUSTOMERS WITH THE EARLIEST DEPOSIT DATES ARE GIVEN FIRST CONSIDERATION. SPECIFIC SLIP ASSIGNMENTS CANNOT BE GUARANTEED AFTER JANUARY 1, 2019.

SLIPS ARE ***NOT*** TRANSFERABLE AND MAY NOT BE SUBLET. SLIP CANCELLATIONS PRIOR TO MARCH 1<sup>st</sup> ARE ENTITLED TO A REFUND, LESS A 30% HANDLING CHARGE AND DEPOSIT. CANCELLATIONS AFTER MARCH 1<sup>st</sup> WILL AUTOMATICALLY FORFEIT ALL SLIP RENTAL FEES. PLEASE NOTE: IF TWO CONSECUTIVE SLIP PAYMENTS ARE MISSED YOU WILL FORFEIT YOUR SLIP UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE. ALL BOATS MUST SUBMIT A CURRENT CERTIFICATE OF INSURANCE TO BE KEPT ON FILE IN THE OFFICE ALONG WITH YOUR REGISTRATION OR DOCUMENTATION NUMBER.

BYYM RESERVES THE RIGHT TO REFUSE ANY APPLICATION AND RE-ASSIGN SLIPS AS DEEMED NECESSARY. ***A 2% ENVIRONMENTAL SERVICE CHARGE WILL BE ADDED TO ALL BILLS. SLIP RENTALS ARE SUBJECT TO 6.35% CONNECTICUT SALES TAX.***
